These are just a few of the goals or achievements you might be interested in. Please Bring or send me other ideas that we can share.



Service OFFICER:

New York State-Specific Changes

- **Gold Star Annuity Expansion:** The Executive Budget for Fiscal Year 2026 includes funding to support legislation that expands eligibility for the Gold Star Annuity. This benefit will now be available to immediate family members of any service member who dies while on active duty, moving beyond the previous combat-only requirement.
- **Funding for Veteran Initiatives:** The budget allocates funds for specific programs:
 - **\$1 million** to expand veteran suicide prevention initiatives, including enhanced risk assessment training, outreach tools, and improved access to mental health services.
 - **\$350,000** for the Military Family Relief Fund to support various relief efforts.
- **NYC Property Tax Exemption:** A new law, effective in late 2025/early 2026, provides a 15% property tax reduction for NYC veterans who served during the Cold War (Sept. 2, 1945, to Dec. 26, 1991, with an honorable discharge). The exemption is larger for disabled veterans and applications must be filed by March 16, 2026, for benefits to begin on July 1, 2026.



- **Housing Assistance:** Over \$68 million in state grants are available to assist low-to-moderate-income families, seniors, and veterans with accessibility upgrades and emergency home repairs. Information on how to apply is available through municipalities and non-profit organizations.
- **Veterans Tuition Award:** Eligibility for the NYS Veterans Tuition Award was recently expanded to include veterans who performed vital service in non-combat areas, opening doors to a wider array of higher education opportunities.
- **"Purple Heart State" Designation:** New York has officially become a "Purple Heart State," which creates opportunities for recognition and potential future legislation like free tuition for Purple Heart recipients.

Federal (Nationwide) Changes Impacting NY Veterans

- **2.8% COLA Increase:** A 2.8% Cost-of-Living Adjustment (COLA) has been applied to various federal VA benefits for 2026, including VA disability pay, Special Monthly Compensation (SMC), Veterans Pension, and Survivors Pension (DIC). The first increased payments were issued on December 31, 2025.
- **MGIB-SR Tuition Fairness Act:** Beginning August 1, 2026, Reservists using the Montgomery GI Bill Selected Reserve will qualify for in-state tuition at public colleges regardless of residency, or the school risks losing VA approval to accept military education benefits.
- **Pact Act Claims:** Veterans are advised to file claims for conditions related to burn pits and other toxic exposures soon, as the VA system is undergoing changes that may impact the claims process in 2026.



- **VA Home Loan Assistance:** The VA now has the authority to offer a "partial claim" program to cover a percentage of a delinquent mortgage for veterans who fell behind on payments between March 2020 and May 2025, to help prevent foreclosures

January 2026 NYS Veterans Home Status Report

1. Current Status (open for business or not; % occupied)

For 2025, the Volunteer department closed out with 200 active volunteers and over 28,000 hours contributed. The Volunteer department is the equivalent of 13.5 full time employees!

Our admissions department kept the home full with a 90.5% occupancy rating—keep in mind we have elected to not fill 30 beds—this number is usually closer to 98-99.8%.

The Adult Day Health Care program had 9,071 visits this year and holds strong with 71 community members enrolled in day care.

2025 was the first full year of no longer utilizing agency staff since covid in 2020—this was a huge milestone for NYS Vets Home and they are proud to have employees that work solely for our residents.

We were successful again in obtaining the nurse retention grant program—over \$500,000 to continue sending nurses to school to pursue their dreams while working at LISVH!

Our telehealth clinic is in the final stages of a complete renovation and will include “offices” and appointment rooms to ensure privacy for our residents while the meet with their providers over skype or zoom. It should be completed over the next 1-2 months.

Friday- Reflections (dementia unit) entertainment- \$150 weekly
