#### What We Do

- At Operation VEST, we promote awareness and inform the public of the staggering statistics affecting our veterans through programs, local events and social media.

# H.R.7589 - REMOVE Copays Act S.4951

117th Congress (2021-2022)

Introduced in House (04/26/2022)

# Reduce and Eliminate Mental Health Outpatient Veteran Copays Act or the REMOVE Copays Act

This bill prohibits the Department of Veterans Affairs (VA) from imposing or collecting any co-payment for the first three mental health outpatient care visits in a calendar year for a veteran who is enrolled in the VA health care system.

**S.4958** - A bill to amend title 38, United States Code, to extend the authority for financial assistance for supportive services for very low-income veteran families in permanent housing, and for other purposes.117th Congress (2021-2022)

### S.4922 - Gerald's Law Act

To amend title 38, United States Code, to provide a burial allowance for certain veterans who die at home while in receipt of hospice care furnished by the Department of Veterans Affairs.

- **S.4766** A bill to amend title 38, United States Code, to revise the rules for approval by the Secretary of Veterans Affairs of <u>commercial driver education</u> programs for purposes of <u>veterans educational assistance</u>, and for other purposes.
- **S. 4721** To amend title 38, United States Code, to <u>increase the amount paid</u> by the Secretary of Veterans Affairs to <u>veterans for improvements and structural alterations</u> furnished as part of <u>home health services</u>.
- **S. 4646** To amend title 38, United States Code, to <u>shorten the timeframe for claims</u> by beneficiaries and the payment of benefits under Department of Veterans Affairs <u>life insurance programs</u>, to <u>improve the management of undisbursed life insurance benefits</u> by the Department of Veterans Affairs, and for other purposes.

Currently from WWII, there are 72,271 still unaccounted for. 7,525 still missing from the Korean. 1,582 American servicemen and civilians still unaccounted for from the Vietnam War, 5 missing from the Gulf War and 126 from the Cold War.

#### Note \*\*

The prominent source of the Axis fuel supply was the Romanian Refineries of Ploiesti. On the first of August 1943, an air attack called operation Tidal Wave was initiated from Libya. A hundred and seventy-seven Liberator's with a total of 1,741 aircrew formed the attack force. The plan of attack was to go in at a low level, 250 feet, to insure maximum effect on the target.

Ploiesti had one of the heaviest and best-integrated air defense networks in Europe and German intelligence was given prior knowledge of a coming raid. So, because of this, operation Tidal Wave became the costliest for the USAAF. With 53 aircraft and 660 aircrew lost. In 1999 the Air War College at Maxwell AFB issued a report stating Ploiești was "one of the bloodiest and most heroic missions of all time."

53 B-24s destroyed (35 claimed by Romanians) 55 B-24s damaged, 310 aircrew killed or missing, 190 aircrew captured or interned. Only 88 Aircraft returned to Libya.

To all those who gave their lives and lay in unmarked repose; may your souls rest with God in eternal peace.
