Legislative:

Concurrent Receipt Update

The Major Richard Star Act (H.R.1282, S.344) has reached a milestone in support with 293 co-sponsors in the House. The House sponsor Rep. Bilirakis (Fla.) will enter this legislation as the first bill to be on the 118th Congress Consensus Calendar. The House must consider at least one measure on the Consensus Calendar during any week in which the House convenes. Entry on the consensus calendar is an achievement that can also further influence negotiations on the FY2024 National Defense Authorization Act (NDAA) during difficult congressional budgetary control measure discussions. Last year, more than two thirds of Congress supported the Star Act with 336 in the House and 67 in the Senate. Members are strongly urged to weigh in on this issue by way of calling, both their house and senate representatives.

News from the VA:

Ending Veteran Homelessness

The Department of Veterans Affairs (VA) recently reported that the agency has exceeded its goal of housing 38,000 homeless veterans by placing 40,401 veterans in permanent housing, which is 6 percent above goal. The VA also noted that 2443 veterans returned to homelessness and of those, 86 percent have been rehoused or are on the path to being rehoused.

Veterans who are experiencing homelessness has decreased by 11 percent since January 2020. In total, the estimated number of veterans experiencing homelessness in America has declined by 55.3 percent since 2010. The Legion has supported initiatives for the VA and other agencies to enhance and invest in efforts to ensure that veteran homelessness is rare, brief, and non-recurring.

Budget Cut Proposals Would Hurt Veterans

WASHINGTON — While the Budget details a plan to honor our country's sacred obligation to care for America's Veterans, their families, caregivers, and survivors, the proposal to cut a broad range of critical programs by 22% would threaten critical services for Veterans — both at VA and across the federal government. The proposed 22% budget cut to VA would:

- Threaten Medical Care for Veterans. The proposal would mean 30 million fewer Veteran outpatient visits, and 81,000 jobs lost across the Veterans Health Administration, leaving Veterans unable to get appointments for care including wellness visits, cancer screenings, mental health services, and substance use disorder treatment.
- Undermine Access to Telehealth. Access to remote care through telehealth is essential for Veterans, particularly in rural areas. By reducing funding for necessary IT infrastructure and support, the proposal would impair VA's ability to expand video-to-home telehealth services and limit the availability of medical equipment that can be provided to Veterans so they can attend important telehealth appointments from home.
- Worsen Wait Times for Benefits. Under the proposal, the Veterans
 Benefits Administration would eliminate more than 6,000 staff,
 increasing the disability claims backlog by an estimated 134,000
 claims and forcing Veterans and their surviving loved ones to wait
 longer for the benefits they have earned, including pensions, life
 insurance, GI Bill educational supports, and employment services.
- Prevent Construction on the Health Care Facilities that Veterans
 need. Veterans deserve to receive care in state-of-the-art facilities, but
 the median VA hospital was built nearly 60 years ago compared to
 just 13 years ago in the private sector. This proposal would cut up to
 \$565 million for major construction projects, including critical clinical
 upgrades to hospitals and clinics. These cuts would negatively impact
 Veteran health care across America.
- Fail to Honor the Memory of All Veterans. The proposal would require VA's National Cemetery Administration to eliminate approximately 500 staff, jeopardize NCA's ability to maintain the final resting place of Veterans to national shrine standards, and delay the opening of 5 new national cemeteries that will serve nearly 1.6 million Veterans and eligible family members.

Beyond the direct impact on Veterans who use VA, these proposed cuts would negatively impact Veterans who access critical services across the federal government. Specifically, these proposed cuts would:

- **Cut Housing for Veterans.** Every Veteran deserves a good, safe home in this country they fought to defend. The proposal would eliminate funding for Housing Choice Vouchers for as many as 50,000 Veterans, putting them at greater risk of homelessness.
- Increase Food Insecurity for Veterans. About 1.3 million Veterans rely on SNAP. This proposal would take food assistance away from Veterans who are older by adding burdensome, bureaucratic requirements, and it would limit states' flexibility to protect especially vulnerable people currently subject to work requirements. That would increase the likelihood that Veterans and their families go hungry.
- Deprive Veterans of mental health, substance use, and other health services. This proposal would mean deep cuts to Department of Health and Human Services community mental health centers, mental health and substance use prevention grants, and other public health programs. Supporting Veterans and their families in the community, especially those not enrolled in VA health care, has been a priority for HHS and these cuts could reduce access to timely care and services.
- Eliminate Job Training and Other Supports to Homeless Veterans. The proposal would mean that 4,200 fewer Veterans experiencing or at risk of homelessness would receive job training, counseling, and job readiness services provided through the Department of Labor's Homeless Veterans' Reintegration Program.

You May Qualify for Disability Benefits

During a recent VA health care appointment, you reported that you may have experienced one or more exposures to herbicides, radiation, and/or toxins during your time in service. Based on your exposure, you may be eligible for disability benefits due to a recent legislative change.

What is Happening

On August 10, 2022, President Biden signed the Sergeant First Class (SFC) Heath Robinson Honoring our Promise to Address Comprehensive Toxics Act of 2022, also known as the PACT Act, into law. This legislation brought about the following changes:

- Expands the list of locations, timeframes, and presumptive conditions related to herbicide exposures.
- Removes the manifestation period and its compensable level requirement for certain disabilities occurring in Persian Gulf War Veterans.
- Expands locations for Persian Gulf War Veterans.
- Expands the list of presumptive conditions and timeframes for certain diseases associated with burn pits and toxic exposures.
- Expands the list of risk activities for radiation exposures.

If you have already filed a disability compensation claim based on the PACT Act, please disregard this letter.

How This May Affect Veterans Exposed to Herbicides

If you were previously denied disability compensation benefits, you may now be eligible and are encouraged to apply if you performed covered service in the following locations during the specified timeframes:

- Thailand at any United States or Royal Thai base during the period beginning January 9, 1962, and ending June 30, 1976, regardless of where on the base you were located or what military job specialty you performed.
- Laos during the period beginning December 1, 1965, and ending September 30, 1969.
- Cambodia at Mimot or Krek, Kampong Cham Province, during the period beginning April 16, 1969, and ending April 30, 1969.
- Guam or American Samoa, or in the territorial waters thereof, during the period beginning January 9, 1962, and ending July 31, 1980.



 Johnston Atoll, or on a ship that called at Johnston Atoll, during the period beginning January 1, 1972, and ending September 30, 1977.

Additionally, two new presumptive conditions associated with herbicide exposure have been added:

- Monoclonal gammopathy of undetermined significance (MGUS)
- Hypertension (also known as high blood pressure)

How This May Affect Persian Gulf War Veterans

If you were previously denied disability compensation benefits, you may now be eligible and are encouraged to apply if you are a Persian Gulf War Veteran and you have an undiagnosed illness or medically unexplained chronic multi-symptom illness (MUCMI). A Persian Gulf Veteran now includes service in Afghanistan, Israel, Egypt, Turkey, Syria, and Jordan, along with those who served in the Southwest Asia theater of operations which includes Iraq, Kuwait, Saudi Arabia, the neutral zone between Iraq and Saudi Arabia, Bahrain, Qatar, the United Arab Emirates, Oman, the Gulf of Aden, the Gulf of Oman, the Persian Gulf, the Arabian Sea, the Red Sea, and the airspace above these locations.

How This May Affect Gulf War Era and Post-9/11 Veterans

You may be eligible for disability compensation benefits and are encouraged to apply if you are a covered Veteran as noted below and you have one of the conditions which are now presumptively associated with exposure to burn pits and other toxins, even if there is no record of evidence of such disease during the period of service.

A "covered Veteran" means a Veteran who performed active military, naval, air or space service while assigned to a duty station in the below locations and timeframes.

How This May Affect Veterans that Participated in a Radiation-Risk Activity

If you were previously denied disability compensation benefits, you may now be eligible for and are encouraged to apply if you participated in one of the following radiation-risk activities:

- participated in the cleanup of Enewetak Atoll during the period beginning January 1, 1977, and ending December 31, 1980.
- participated onsite in the nuclear response effort following the collision of a United States Air Force B–52 bomber and refueling plane that caused the release of four thermonuclear weapons in the vicinity of Palomares, Spain, during the period beginning January 17, 1966, and ending March 31, 1967.
- participated onsite in the nuclear response effort following the on-board fire and crash of a
 United States Air Force B-52 bomber that caused the release of four thermonuclear weapons
 in the vicinity of Thule Air Force Base, Greenland, during the period beginning January 21,
 1968, and ending September 25, 1968.

What We Need from You

- If you have not previously submitted a disability compensation claim for your exposure-related disability and would like to do so, please submit VA Form 21-526EZ, Application for Disability Compensation and Related Compensation Benefits.
- If you have previously submitted a claim for disability compensation for your exposurerelated disability but were not found eligible, please submit VA Form 20-0995, Decision Review Request: Supplemental Claim.
- If you wish, you may submit additional evidence, such as medical records or a biopsy report, with your application. Also, VA can assist you in gathering new and relevant evidence to support your claim.
